## MIXING INSTRUCTIONS:

**PESTICIDES:** Follow pesticide label for mixing instructions with liquid fertilizers and make a jar test to ensure proper compatibility. Then mixing sequence:

1. Water
2. LIQUID BORON
3. Pesticide

Agitate throughout to assure proper mixing.

**FERTILIZER:** Follow this sequence,

1. 1/3 of liquid fertilizer
2. 1/2 tank of water
3. LIQUID BORON
4. Balance of water and liquid fertilizer

Agitate throughout mixing to assure proper mix.

Net weight per gallon: 10.8 pounds.

## GENERAL RECOMMENDATIONS:

TEVA LIQUID BORON 10% is designed for use in all liquid fertilizers (except aqua ammonial) and suspensions as a soil application for all crops requiring Boron.

## SOIL APPLICATION:

Do not place in direct contact with seed or starter fertilizer. LIQUID BORON 10% should be incorporated into the soil.

## ROW or BAND APPLICATION:

Apply 8-16 ounces LIQUID BORON 10% per acre, just before planting.

## BROADCAST APPLICATION:

Apply 2-4 quarts per acre of LIQUID BORON 10%, just before planting.

**NOTE:** When applying TEVA LIQUID BORON 10% in a foliar application, use 8-16 ounces per acre, per application.

Optimum rate of application will vary between fields, depending on soil pH and organic matter content. For best results, follow soil test or plant analysis recommendations.
